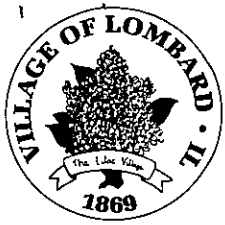

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B I" liquor license, contained therein, to read as follows:

Class "A/B I" - 9

This decrease in Class "A/B I" liquor license reflects a classification change to Pavmar Enterprises Inc. d/b/a Praga located at 229 W. St. Charles Road, Lombard.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "N" liquor license, contained therein, to read as follows:

Class "N" - 2

This increase in Class "N" liquor license reflects the issuance of a Class "N" liquor license to Pavmar Enterprises Inc. d/b/a Praga located at 229 W. St. Charles Road, Lombard..

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
