Staff is forwarding a recommendation from the Environmental Concerns Committee to amend the Solid Waste Contract to shorten the end of the yard waste collection period. Per the Contract, yard waste is collected from the first full week of April through the second full week of December. The Village pays Waste Management to collect bundled brush at no cost to residents during this period.

Based on subsequent discussions with Waste Management, the last two weeks of the yard waste in December could be eliminated to reduce the Village's cost for bundled brush by \$8,600. Thus, the collection would end on the last full week in November. Most other municipalities end their collections at the end of November so Lombard's collection period is unusually long. Waste Management has advised that very little volume is collected in December.

While the Committee found that this change is prudent for wise use of tax monies, it will not make up for the forecasted shortfalls in the Community Recycling Fund of FY12B and FY13 of \$13,800 and \$22,200, respectively. The main reason for the funding shortfall is due to fewer paid refuse accounts due to vacancies, foreclosures and non-payments. The monthly electronics collections will help make up a large portion of the remaining shortfall. However, later this year, the Committee will revisit the question of revenue and expenditures in order to balance the Community Recycling Fund and may propose to reinstate some level of funding for grant programs. Currently, all grant programs in the Community Recycling Fund are unfunded in both FY12B and FY13.

# Recommendation:

Staff concurs with the Committee's recommendation that the Board of Trustees approve amending the Solid Waste Contract to change to the end of the yard waste ollection period to be the last full week in November. Staff would publicize the change to the collection period in the Fall.

### AGREEMENT TO AMEND A CONTRACT

This Agreement (the "Agreement") made and entered into this 17<sup>th</sup> day of May 2012, by and between the Village of Lombard (the "Village") and Waste Management of Illinois, Inc., an Illinois Corporation (the "Contractor"). The Village and Contractor being sometimes referred to herein collectively as the "Parties".

WHEREAS, on March 19, 2009 the Village and Contractor executed a Solid Waste Collection and Disposal Services Contract (the "Contract") on August 19, 2010 and;

WHEREAS, the Contract contains a provision in Section 8B(1) to provide a yard waste collection service from the first full week of April through the second full week of December;

WHEREAS, the Contract contains a provision in Section 8B(7) to provide a brush collection service from the first full week of April through the second full week of December;

WHEREAS, the Contract contains a provision in Section 36 for amendments to be in writing and signed by both Parties;

NOW, THEREFORE, for and in consideration of the foregoing and various covenants in said agreement and the mutual covenants herein contained, it is agreed by and between the parties as follows:

SECTION 1: The aforementioned Contract shall be amended as follows:

Section 8B(1) shall state that the yard waste collection service shall normally end on the last full week in November.

Section 8B(7) shall state that the brush collection service shall normally end on the last full week in November.

SECTION 2: The Contractor shall provide the Village with a credit of eight thousand six hundred dollars (\$8,600) annually in consideration of this Agreement.

SECTION 3: All other terms, covenants and conditions of said contract heretofore executed which are not amended or deleted herein shall remain in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this document to be signed by duly authorized officers who have set their hands and seals the day and year set forth above.
