Trustee Brian LaVaque, Alternate Chairperson of the Economic & Community Development Committee, reported the following:
At the June 10 meeting of the Economic & Community Development Committee, members discussed economic incentive request amendments for the proposed Prairie Food Co-op grocery store at Eastgate Shopping Center. This request, which is still being developed, was requested in light of proposed State legislation which would amend the grocery tax program by the State. The Committee unanimously recommended that staff and Counsel work with PFC on an agreement with alternate funding sources for future consideration by the Village Board.

The Committee also heard a presentation by Choose DuPage regarding their new Municipal Analytics Program, which is intended to provide access a broad range of economic development tools and resources to address economic development data inquiries for the Village. The ECDC unanimously approved an annual expenditure of \$5,000 for the Village of Lombard to become a Program partner.

B. 240168 PC 24-06: 855 E. Roosevelt Road - Creekview Plaza

The Plan Commission submits its recommendation to approve the following action on the subject property located within the B4A Roosevelt Road Corridor District, to provide for the construction of a new principal building:

- Amend the approvals previously requested through Plan Commission petition PC 22-05, and granted by Ordinance No. 8077, as follows:
 - a. Preservation of the existing conditional use under Ordinance No. 8077, under Sections 155.103(F) and 155.417(G)(2)(a) (vii) of the Zoning Ordinance to allow a second-floor restaurant and banquet, including entertainment and dancing when conducted as part of the restaurant and banquet operations and secondary to the principal use subject to the conditions numbered 2, 3, 7, 10, and 11 (dining and banquet limit of 156) set forth in Section 14 of said ordinance.
 - A new conditional use under Sections 155.103(F) and 155.417(G)(2)(b)(iv) of the Zoning Ordinance to allow for a drive-through facility.
 - c. Elimination of the following conditional uses approved in Ordinance No. 8077 (Secs. 2-3) under Sections 155.103(F), 155.417(G)(2)(c)(vii), and 155.417(G)(l0)(b) of the Zoning Ordinance: (a) a building containing a restaurant as a principal use that will exceed 40 feet in height; and (b) outdoor display and sales on a seasonal or periodic basis in a row of parking or on the rooftop.
 - d. Preservation of the existing variations under Ordinance No. 8077, under Sections 155.102(B)(3) and 155.103(C)(2)(b), from Sections 155.417(G)(I2), 155.417(G)(I4) and 155.602(A)(10)(d) of the Zoning Ordinance which require parking lot lighting to be directed away from the lot lines and to fall below certain maximum intensities in order to avoid these requirements for lighting adjacent to the access easement serving the subject property and the easterly adjacent property subject to the conditions numbered 2, 3, 7, 10 set forth in Section 14 of said ordinance.
 - e. Preservation of the existing variations under Ordinance No. 8077, under Sections 155.102(B)(3) and 155.103(C)(2)(b), from Section 155.707(B)(4)(d) which requires transition yard

- areas not planted with trees or shrubs to be maintained as lawn in order to permit the south lot line to be maintained with all trees and understory plant material to remain in the wetland, flood way and floodplain reflected in the plans (affects south transition yard except east +/-45 feet) subject to the conditions numbered 2, 3, 7, and 10 set forth in Section 14 of said ordinance.
- f. Preservation of the existing variations under Ordinance No. 8077, under Sections 155.102(B)(3) and 155.103(C)(2)(b), from Section 155.708 which requires a ten-foot foundation landscaping area on all sides of a building in order to allow development without foundation landscaping according to the Landscape Plan subject to the conditions numbered 2, 3, 7, and 10 set forth in Section 14 of said ordinance.
- g. Preservation of the existing variations under Ordinance No. 8077, under Sections 155.102(B)(3) and 155.103(C)(2)(b), from Article XI which imposes several detailed landscaping requirements in Sections 155.701 through 155.710 in order to accomplish innovative landscaping shown in the four-sheet landscape plan on file with the Village for the benefit of natural areas on the site and to the south as well as residential neighbors to the south subject to the conditions numbered 2, 3, 7, and 10 set forth in Section 14 of said ordinance.
- h. A new variation from under Sections 155.102(B)(3) and 155.103(C)(2)(b), from Section 155.603 to allow off-street loading to occur in the bypass lane on the east side of the drive-through lane.
- Elimination of the following variations approved in Ordinance No. 8077 (Secs. 4, 5, 7, 8) under Sections 155.102(B)(3) and 155.103(C)(2)(b) of the Zoning Ordinance: (a) parking variations from Section 155.417(G)(12) and 155.602(C) (Table 6.3); (b) loading variations from Sections I55.4I7(G) (I2) and I55.603(A); (c) landscape island variations for rickshaws from Sections 155.417(G)(I2) and 155.706(B)(2) (c); (d) landscape and rickshaw lighting variations from Section 155.417(G)(I4).
- j. Approval of a revised site plan and landscaping plan under Section 155.103(I) and Section 155.702 of the Zoning Ordinance subject to the conditions numbered 2, 3, 7, 10 set forth in Section 14 of Ordinance No. 8077.
- Approval of a preliminary and final plat of subdivision for Creekview/Pep Boys Resubdivision No. 1 which is intended merely to release the access restriction on the driveway at the west end of the reciprocal access easement. (DISTRICT #6)

Director of Community Development Bill Heniff provided an overview

of a Powerpoint presentation regarding PC 24-06, 855 E. Roosevelt Road - Creekview Plaza.

Ken Franklin, resident living behind the property, spoke regarding the proposed Creekview Plaza.

Diane Bellows, resident, spoke questioning number of variances; drive-thru/loading noise; hours of operation; 24-hour coffee; and the banquet hall open until 2:00 am.

Carolyn King, resident, spoke about too many dead/empty strip malls on Roosevelt Road and how we need more green space.

Doris Dornberger, resident, spoke expressing concerns about hours of operation and parking.

Mark Daniel, attorney for petitioner, spoke about the hours of operation; the business decision based on the zoning ordinance; and noted there are no firm answers at this time. He stated the fence is a go, but the contractor is against the fence.

Director of Community Development Bill Heniff spoke about the hours of operation and the liquor license code which allows for 1:30 am last call and 2:00 am closing. He stated the other items are on a case-by-case basis. There are two tenants with other possible tenants in mind and trying to stay in the retail space.
