Gold Fish Restaurant, Inc. d/b/a Kyo Ramen & Poke Bowl

The Village has received a request for a Class "U" liquor license (to serve full alcohol) from Gold Fish Restaurant, Inc. d/b/a Kyo Ramen & Poke Bowl located at 108 W. St. Charles Road. The alcohol includes beer, wine, sake, and cocktails.

Kyo Ramen & Poke Bowl is a full-service Japanese restaurant with seating. The license is for the January 1 - June 30, 2024, licensing term.

## AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF CLASS "U" LIQUOR LICENSES

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class "U" liquor license category, to read in its entirety as follows:

"Class "U" - 3"

This increase in the number of Class "U" liquor licenses reflects the issuance of a new Class "U" liquor license to Gold Fish Restaurant, Inc. d/b/a Kyo Ramen & Poke Bowl located at 108 W. St. Charles Road, Lombard, Illinois.

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
