On December 6, 2010, we received a call to Glass Courts Fitness Club for a person that had fallen. While en route, we were notified by the Police that the patient was in Cardiac arrest. Upon arrival of the Lombard Police Department, the patient was being attended to and receiving CPR from John Adam, a fellow health club member and Lombard citizen.

Prior to Lombard Police and Fire companies arriving, bystander John Adam was working out and noticed the man next to him fall. Upon checking on his condition, he realized the person was not breathing or responding in anyway. John called out for help and activated the "9-1-1" sequence by having other health club members call for help.

John began CPR on the unresponsive man. Although trained many years ago in CPR, per Lombard Police, John was doing an excellent job. Care was then taken over by the Lombard Police and Fire personnel.

On this call, Lombard Citizen John Adam became an integral part of the successful resuscitation of a fellow Citizen. He "recognized" the seriousness of the situation and "responded" with appropriate actions to the aid of a fellow citizen. There is no question his actions made a difference in the full recovery of our patient and to the quality of life after recovery. For this effort, Mr. John Adam should be recognized as an outstanding citizen and "Good Neighbor".
