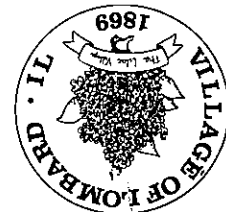

Subject: Replacement of police car due to total loss accident

A Lombard Police squad car (unit # PP728) was involved in an accident on October 27, 2008 resulting in a total loss of this car. Additionally some equipment in the car was damaged that will cost approximately \$1,000 to replace. The insurance company involved has been contacted and settlement details are being worked out. Based on progress to date we can expect \$13,600 in reimbursement for this car. State bid for this type of vehicle has been awarded to Morrow Brothers Ford of Greenfield (IL). The cost of a new car is \$21,452.

I request the B.O.T. waive bid, purchase on state contract # 4014905 and award a contract to Morrow Brothers Ford of Greenfield (IL) in the amount of \$21,452 for a new Ford Crown Vic squad car. Please submit this item to the Village Board for their consideration at the December 18, 2008 meeting.
