SUBJECT: Ordinance Amending Title 11, Chapter 116 of the Lombard Village Code

**Business Licenses and Business Name Changes** 

Attached is an ordinance amending Village Code Title 11, Chapter 116 (Licensing) adding a new Section 116.06 giving the Village of Lombard the ability to charge a nominal fee when a licensed business wants to change their business name but the location and the ownership of the business remain the same.

### **Background:**

When there is a request from a business owner, who has a business that holds one or multiple business license(s), to change their business name, the Village of Lombard incurs certain costs (e.g. staff time, usage of special stationery and envelopes, postage) as a result of accommodating such a change. In an effort for the Village of Lombard to recover these costs, staff is recommending that a fee of \$10.00/license be charged. The practice of recovering licensing costs currently exists under Title 11, Chapter 112 (Alcoholic Beverages) Section 112.22 which allows the Village of Lombard to charge a liquor licensee \$15.00 when they change their business name. This proposed ordinance would mirror this existing practice under the Licensing section of Village Code.

#### Recommendation:

That the Village Board of Trustees approve an Ordinance amending Title 11, Chapter 116 of the Lombard Village Code in regard to business licenses and business name changes.

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 116 OF THE LOMBARD VILLAGE CODE IN REGARD TO BUSINESS LICENSES AND BUSINESS NAME CHANGES

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 116 of the Lombard Village Code is amended by adding a new Section 116.06 thereto, which shall read in its entirety as follows:

## "§ 116.06 Change of business name.

Any licensee or permittee, holding a business related license or permit issued by the Village under Title 11 of the Village Code, other than under Chapters 112, 117, 118, 123 or 126 of Title 11, that changes the name of the business, but does not change the location or ownership of the business, shall, within thirty (30) days of the name change, notify the Village's Business Administrator, and pay a fee of ten and no/100 dollars (\$10.00) per license or permit, so that an updated license and/or permit, containing the new business name, can be issued by the Village to the licensee and/or permittee relative to said business."

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
