ORDINANCE NO. 6741

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AND THE CLASS "L" LIQUOR LICENSE CATEGORY

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by revising the language contained therein, relative to the Class "L" liquor license category, to read in its entirety as follows:

"Class "L" – The sale of beer and wine only, by the glass, for consumption on the premises, in conjunction with the package sales of beer and wine only. Beer and wine tastings shall be allowed, with or without a charge therefor."

SECTION 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language contained therein, relative to the Class "L" liquor license category, to read in its entirety as follows:

"Class "L" - 1"

That the Class "L" liquor license, referenced in this Section, reflects the issuance of a Class "L" liquor license to UnCork It, LLC d/b/a The Vino Cellar, located at 141 West St. Charles Road, Lombard, Illinois.

SECTION 3: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the language contained therein, relative to the Class "L" liquor license category, to read in its entirety as follows:

"Class "L" - \$750"
