ORDINANCE NO. 4988

ORDINANCE VACATING A PORTION OF KRAMER AVENUE RIGHT-OF-WAY

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: It is hereby determined that the public interest will be subserved by vacating Kramer Avenue hereinafter described.

SECTION 2: That the street described as follows:

THAT PART OF KRAMER AVENUE LYING SOUTH OF THE SOUTHERLY LINE OF WESTERN AVENUE AND NORTH OF THAT PORTION OF VACATED KRAMER AVENUE, IN SUNNYSIDE ADDITION TO LOMBARD BEING A SUBDIVISION IN THE SOUTHEAST QUARTER OF SECTION 5 TOWNSHIP 39 NORTH RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT OF SAID SUNNYSIDE ADDITION TO LOMBARD, RECORDED APRIL 25, 1925 AS DOCUMENT 191820, IN DU PAGE COUNTY, ILLINOIS.

And as shown on the plat attached hereto as Exhibit "A" and designated "hereby vacated" be and the same hereby is vacated,

SECTION 3: That the Department of Community Development is hereby directed to record a certified copy of this Ordinance, along with the original Plat of Vacation with the DuPage County Recorder of Deeds.

SECTION 4: That this ordinance shall be in full force and effect from and after its passage and approval as provided by law.
