**SUBJECT:** **Title 11, Chapter 112, of the Lombard Village Code**  
**Wineski's, Inc. – 854 N. Ridge Ave.**

The Village has received a request for a liquor license from Wineski's, Inc. located at 854 N. Ridge Avenue. Wineski's will warehouse and sell package sales of wine and champagne only for delivery to members of a wine club. The licensed premises will not be open for entry by the public.

Currently, Village Code does not have a liquor license classification that would fit Wineski's liquor license request. Staff met with the applicant and thereafter requested that Village Counsel prepare an ordinance creating a new Class "FF" liquor classification as well as to amend other sections of Code within Chapter 112 which will be affected by the creation of the "FF" liquor classification.

The petitioner has requested that first reading be waived so that they can secure their Village and State licenses in anticipation of their opening date.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE  
LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES  
AND A NEW CLASS "FF" LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title XI., Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "FF" liquor license category, to read in its entirety as follows:

"Class "FF" – Package sales of wine and champagne only, for delivery to members of a wine club, in response to internet orders, telephone orders and mail orders. The deliveries of the wine and champagne, to the members, shall take place in a manner other than on the licensed premises. The licensed premises shall not be open for entry by the public; however, all sales, of the wine and champagne that is delivered to the members, shall be consummated in a manner that provides for the sales tax on such sales to come to the Village."

**SECTION 2:** That, effective June 1, 2016, Title XI., Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding language relative to a new Class "FF" liquor license thereto, which shall read in its entirety as follows:

"Class "FF" – 1"

This increase in the number of Class "FF" liquor licenses reflects the issuance of a Class "FF" liquor license to Wineski's, Inc., located at 854 North Ridge Avenue, Lombard, Illinois 60148.

**SECTION 3:** That Title XI., Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "FF" liquor license category, to read in its entirety as follows:

"Class "FF" – \$500.00"

**SECTION 4:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
