Subject: Sidewalk Snow Removal Contract Renewal

The Village of Lombard opened bids for the Snow and Debris Hauling on December 7, 2012. The lowest responsible bidder was received from Nagle Trucking and Materials. The original contract is in effect from January 1, 2013 to December 31, 2013.

Nagle Trucking and Materials has agreed to maintain their prices from the 2013 contract for the 2014 contract. Nagle tucking and Materials has provided good service to the Village. The FY14 budget includes \$20,000.00/year for this service.
