Over the years, the definition of small industrial business appears to have expanded; and the noise level for the property located in the Limited Industrial District has increased substantially.
- c) There are no guarantees of the hours within which equipment and materials will be moved. In the past, businesses had stated that it would only be between 8 am to 5 pm. However, as homeowners and residents of Arboretum Park Condominiums, we have endured noise from the Limited Industrial District, including loud music and semi-trucks, well into the night and past the stated 5 pm time.
- d) Areas of the Limited Industrial District have not been properly maintained, including cutting of trees and weeds and removal of litter.
