The Village of Lombard has standardized on the use of Dell computer equipment, to include computers, servers, laptops, and monitors. All Village computer equipment has a replacement lifecycle that is used as a means of ensuring that Village staff are utilizing up to date equipment and software to operate as secure and efficiently as possible. The Village budgets for these replacements based on the expected lifecycle of equipment on an annual basis from the Technology Reserve Fund.

This year, the Village has 3 Servers and 1 Storage Appliance that have reached the end of their lifecycle and need to be replaced. We are replacing these 3 devices with 2 servers that also serve as storage appliances.

This is a budgeted request that will come from Technology Reserve Hardware (640.840.840.73920). No other proposals were pursued since the Village has standardized on the use of Dell server equipment.

Staff recommends the Village Board of Trustees approve a proposal from Dell in the amount of \$60,416.54, for the purchase of Dell Servers.
