Ordinance Amending Title 11, Chapter 112, Section 112.13 (A) of the Lombard

Village Code - Residence Inn Chicago Lombard - 2001 S. Highland Avenue

Residence Inn by Marriott LLC d/b/a Residence Inn Chicago Lombard currently holds a Class "T-1" liquor license. This classification allows beer and wine only served at no charge for consumption by patrons of the hotel (manager's reception) on the premises of a hotel without a restaurant along with the packaged sale of beer and wine only to patrons of the hotel.

The Village of Lombard has received notice that the current license holder, Residence Inn by Marriott LLC will no longer be the operator of the hotel. The Village of Lombard has received a request from the new operator, Interstate Management Company LLC d/b/a Residence Inn Chicago Lombard for a Class "T-1" liquor license to operate at the same location. Attached is an ordinance decreasing and increasing the number of Class "T-1" licenses by one to account for the new operators.

Staff is requesting a waiver of first reading in order to accommodate their request.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "T-I" liquor license category, contained therein, to read as follows:

Class "T-I" -0

This decrease in the number of Class "T-I" liquor licenses reflects the ceasing of business by Residence Inn by Marriott LLC d/b/a Residence Inn Chicago Lombard, located at 2001 S. Highland Avenue, Lombard, Illinois, and the termination of the Class "T-I" liquor license issued to Residence Inn by Marriott LLC in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "T-I" liquor license category, contained therein, to read as follows:

Class "T-I" – 1

This increase in the number of Class "T-I" liquor licenses reflects the issuance of a Class "T-I" liquor license to Interstate Management Company LLC, who will be operating the business commonly known as Residence Inn Chicago Lombard, located at 2001 S. Highland Avenue, Lombard, Illinois.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
