

SUBJECT: **Liquor License Classification Change-Viceroy of India**

Please be advised liquor license holders with a Class A/B license are required to report their annual gross dollars of liquor sales yearly. Viceroy of India located at 233 E. Roosevelt Road reported a decrease in their 2006 sales which changes their classification from a Class A/B II to a Class A/B I.

ORDINANCE _____
AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B II liquor licenses, contained therein, to read as follows:

Class "A/B II - 8

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B I liquor licenses, contained therein, to read as follows:

Class "A/B I - 5

Section 3: That the changes in the number of Class A/B liquor licenses set forth in Sections 1 and 2 above are as a result of Viceroy of India, 233 E. Roosevelt Road, reporting an decrease in their gross dollars of liquor sales in calendar year 2006, resulting in a change from Class A/B II to Class A/B I1.

Section 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
