ORDINANCE NO. _____

**AN ORDINANCE REPEALING
TITLE 9, CHAPTER 96 OF THE
LOMBARD VILLAGE CODE IN REGARD TO
THE HELEN M. PLUM LIBRARY**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: The President and Board of Trustees find as follows:

- A. That the provisions of Title 9, Chapter 96 of the Lombard Village Code were enacted by the Village when the Helen M. Plum Library was a Village Library, subject to the provisions of the Illinois Local Library Act (75 ILCS 5/1-0.1 *et seq.*).
- B. That, during 2010, the Helen M. Plum Library converted from a Village Library to a Library District, pursuant to the provisions of 75 ILCS 16/10-5 *et seq.*
- C. That, as the Helen M. Plum Library is now a Library District, subject to the provisions of the Public Library District Act of 1991 (75 ILCS 16/1-1 *et seq.*), there is no longer a need for Title 9, Chapter 96 of the Lombard Village Code.

SECTION 2: That, based on the findings set forth in Section 1 above, Title 9, Chapter 96 of the Lombard Village Code is hereby repealed.

SECTION 3: That this Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.
