## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, OF THE LOMBARD VILLAGE CODE IN REGARD TO THE ELIMINATION OF CLASS "N", "P", "V" AND "W" LIQUOR LICENSE CLASSIFICATIONS

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 112 of the Lombard Village Code is amended by repealing the following provisions thereof:

- A. The provisions within Section 112.12(A) relative to the Class "N","P", "V" and "W" liquor licenses.
- B. The provisions within Section 112.13(A) relative to the Class "N","P", "V" and "W" liquor licenses.
- C. The provisions within Section 112.14(A) relative to the Class "N","P", "V" and "W" liquor licenses.

SECTION 2: That Title 11, Chapter 112, Section 112.35 of the Lombard Village Code is amended by revising the reference therein to "class "G", "H", or "N" license", to read "class "G" or "H" license."

SECTION 3: That Title 11, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to "all Class A/B-I, A/B-III, C, D, F, G, H, I, K, L, M, N, O, P, R, S, T, U and V liquor license holders," to read, "all Class A/B-I, A/B-III, A/B-III, C, D, E-1, E-II, I, K, L, M, O, R, T, X and Z liquor license holders."

**SECTION 4**: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
