



**AN ORDINANCE APPROVING TEXT AMENDMENTS
TO THE LOMBARD ZONING ORDINANCE
TITLE 15, CHAPTER 155, SECTIONS 155.415(C), 155.416(C),
155.417(G)(2)(b), AND 155.802
OF THE LOMBARD VILLAGE CODE**

PC 14-18: Tattoo Studio Definition and Regulations

WHEREAS, the Village of Lombard maintains a Zoning Ordinance which is found in Title 15, Chapter 155 of the Lombard Code; and,

WHEREAS, the Board of Trustees deem it reasonable to periodically review said Zoning Ordinance and make necessary changes; and,

WHEREAS, a public hearing to consider text amendments to the Zoning Ordinance has been conducted by the Village of Lombard Plan Commission on July 21, 2014 pursuant to appropriate and legal notice; and,

WHEREAS, the Plan Commission has filed its recommendations with the President and Board of Trustees recommending approval of the text amendments described herein; and,

WHEREAS, the President and Board of Trustees approve and adopt the findings and recommendations of the Plan Commission and incorporate such findings and recommendations herein by reference as if they were fully set forth herein;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Title 15, Chapter 155, Section 155.415(C) of the Lombard Village Code is hereby amended as follows:

- A. Subsections (29) through (31), inclusive, are hereby renumbered as subsections (30) through (32), respectively.
- B. A new subsection (29) shall be added thereto, to read in its entirety as follows:

“(29) Tattoo Studio.”

SECTION 2: That Title 15, Chapter 155, Section 155.416(C) of the Lombard Village Code is hereby amended as follows:

A. Subsections (31) through (34), inclusive, are hereby renumbered as subsections (32) through (35), respectively.

B. A new subsection (31) shall be added thereto, to read in its entirety as follows:

“(31) Tattoo Studio.”

SECTION 3: That Title 15, Chapter 155, Section 155.417(G)(2)(b) of the Lombard Village Code is hereby amended by adding a new subsection (xiv) thereto, which shall read in its entirety as follows:

“(xiv) Tattoo Studio “

SECTION 4: That Title 15, Chapter 155, Section 155.802, of the Lombard Village Code, is hereby amended by inserting the following definitions for “body piercing”, “tattoo studio” and “tattooing” at the appropriate alphabetical location therefor:

“Body piercing means penetrating the skin to make a hole, mark, or scar that is generally permanent in nature. Body piercing does not include practices that are considered medical procedures or the puncturing of the outer perimeter or lobe of the ear using a pre-sterilized, single-use stud and clasp ear piercing system.”

“Tattoo studio is any room or space where tattooing or body piercing, or a combination thereof, is practiced or where the business of tattooing or body piercing is conducted, or any part thereof.”

“Tattooing means making permanent marks on the skin of a live human being by puncturing the skin and inserting indelible colors. Tattooing includes imparting permanent makeup on the skin, such as permanent lip coloring and permanent eyeliner. Tattooing does not include any of the following:

- (1) The practice of electrology as defined in the Electrology Licensing Act.
- (2) The practice of acupuncture as defined in the Acupuncture Licensing Act.
- (3) The use, by a physician licensed to practice medicine in all its branches, of colors, dyes, or pigments for the purpose of obscuring scar tissue or imparting color to the skin for cosmetic, medical, or figurative purposes.”

SECTION 5: That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.






