TITLE: An Ordinance Amending the Lombard Village Code Title 9, Chapter 91, Section 91.21 in Regard to Emergency Medical Services

BACKGROUND/POLICY IMPLICATIONS:

An increase to the National Medicare Fee Schedule was recently issued by the Health Care Financing Administration and took effect on January 1, 2009. Staff recommends that we increase our Emergency Medical Services fee schedule to realize the increase in reimbursement from Medicare. The following outlines our current charges as well as the January 1, 2009 allowable charges per the Medicare Fee Schedule for residents of Lombard as well as the residents of the Glenbard Fire Protection District. As in the past, non-residents will continue to pay a rate of \$100 above the Medicare Reimbursement levels, except for Advanced Life Support (Treat/No Transport) which is at a rate of \$75 for non-residents.

Mileage Rate	\$6.42 per mile	\$6.87 per mile

**ORDINANCE AMENDING TITLE 9, CHAPTER 91,  
SECTION 91.21 OF THE LOMBARD VILLAGE CODE  
IN REGARD TO EMERGENCY MEDICAL SERVICES**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Title 9, Chapter 91, Section 91.21 (A) & (B) of the Lombard Village Code is amended to read in its entirety, effective January 1, 2009, as follows:

§91.21 FEES

(A) Fees are hereby imposed upon residents and non-residents of the Village of Lombard using Emergency Medical Service provided by the Village of Lombard at the following rates:

Service	Resident Village	Glenbard Fire Protection District Resident	Non-Village/Non-Glenbard Fire Protection District Resident
Basic Life Support (BLS)-Transport	\$360.00	\$360.00	\$460.00
Advanced Life Support-Level I (ALS-I)-Transport	\$430.00	\$430.00	\$530.00
Advanced Life Support-Level II (ALS-II)-Transport	\$620.00	\$620.00	\$720.00
Advanced Life Support (ALS) Treatment, but no Transport	\$ 50.00	\$ 50.00	\$ 75.00

(B) In addition to the fees set forth in subsection (A) above, a mileage fee shall be charged in regard to Emergency Medical Transportation Service provided by the Village at the rate of \$6.87 per mile.

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form as provided by law.
