Final Invoice from the State of Illinois through the Illinois

Department of Transportation (IDOT)

The original estimated Village Share was \$2,053,412 of the \$26,881,958 project. The awarded Contract amount was \$27,843,513.62. There was an amendment to the Intergovernmental Agreement with IDOT for \$8,568 for Emergency Pre-emption at North Avenue and Route 53, bringing the estimated Village share to \$2,061,980. The Final Cost of the project is \$29,113,396.24. The final cost to the Village for the project is \$2,379,237.23, which represents quantity adjustments to the existing contract items based on field measured quantities for a final Increase to the contract in the amount of \$317,257.23. This is a summary spreadsheet of the changes:

The original IGA was not adjusted for the actual contract amount (+3.58% or \$73.5K). Another reason for the increase in the cost was additional watermain and sewer items such as oversized watermain (\$14K), Additional water valves (\$16K), Repair leaking sanitary sewer (\$18K), Replacing sanitary sewer (\$14K), Relocating sanitary sewer (\$15K). These were items added in the field as force accounts and resulted in \$124K of increased cost to the contract. In addition, one item which had no plan quantity was trench backfill resulting in an addition of \$293K.

Please present Amendment 4 to the IGA between Lombard and the State of Illinois to the President and Board of Trustees for their review and approval at their regular meeting on April 16, 2009. If approved, please have two signed copies returned to Engineering for further processing.

FOURTH AMENDMENT TO THE AGREEMENT BETWEEN THE VILLAGE OF LOMBARD AND THE STATE OF ILLINOIS THROUGH THE ILLINOIS DEPARTMENT OF TRANSPORTATION (ILLINOIS ROUTE 64 RECONSTRUCTION PROJECT)

THIS FOURTH AMENDMENT ("Fourth Amendment") made and entered into this <u>16th</u> day of <u>April</u>, 2009, by and between the VILLAGE OF LOMBARD (the "VILLAGE") and The STATE OF ILLINOIS, through the Illinois Department of Transportation (the "STATE").

WHEREAS, on June 20,2002 the VILLAGE and STATE entered into an Intergovernmental Agreement in regard to certain infrastructure improvements relative to the ILLINOIS ROUTE 64 RECONSTRUCTION PROJECT (the "Original IGA"); and

WHEREAS, the Original IGA has been amended three (3) times, pursuant to amendments dated December 5, 2002, September 4, 2004 and May 4, 2006 (the Original IGA as amended by said amendments being herein after referred to collectively as the "Amended IGA"); and

WHEREAS, as a result an increase in the quantities used in completing the ILLINOIS ROUTE 64 RECONSTRUCTION PROJECT the VILLAGE and STATE have agreed to increase the dollar amounts set forth in the Amended IGA to reflect actual costs;

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the VILLAGE and the STATE as follows:

- 1: The aforementioned recitals are incorporated herin by reference.
- 2: That Section 4 of the Amended IGA ishereby further amended the construction cost dollar amount to read, "\$29,113,396.24" and the VILLAGE's share dollar amount to read, "2,379,237.23".
- 3: All other terms, covenants and conditions of the Amended IGA, which are not amended or deleted hereby shall remain in full force and effect.
