



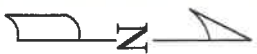

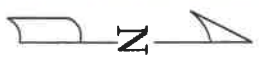
BACKYARD FLOODING LOCATIONS

January 11, 2000

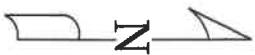
1. **Hammerschmidt & New St.** – Too low to drain to the new Hammerschmidt School detention pond. Consider pumping or property acquisition. **Warning:** local storm sewers recombine.
2. **100 block East Washington** – More information needed.
3. **Washington, Edgewood, Fairfield, Madison** – Combined sewer area. No nearby detention.
4. **305 S. Lombard** – Combined sewer area. No nearby detention.
5. **Highland & Maple** – Combined sewer area. May be possible to route to Gatz Pond which would provide detention. **Warning:** Gatz Pond outfall recombines. Separation of Gatz Pond outfall preferred.
6. **Chase, Emerson, Lodge, St. Charles Place** -- Combined sewer area. May be possible to route to Gatz Pond which would provide detention. **Warning:** Gatz Pond outfall recombines. Separation of Gatz Pond outfall preferred.
7. **Highland, Chase, Great Western Trail** -- Combined sewer area. May be possible to route to Gatz Pond which would provide detention. **Warning:** Gatz Pond outfall recombines. Separation of Gatz Pond outfall preferred.
8. **Ahrens, St. Charles, Westmore-Meyers, Union Pacific R.R.** – New storm sewers on Ahrens and St. Charles route to Gatz Pond. Westmore-Meyers is combined. Gatz Pond potential outfall. **Warning:** Gatz Pond outfall recombines. Separation of Gatz Pond outfall preferred.
9. **Prairie & Martha** – Low spot on block. Storm sewers surcharge, overtop curb and driveway, collect in side and rear yards. More information needed on solutions.
10. **100 block West Crystal** – Low spot on block. Storm sewers surcharge, overtop curb and driveway. Too low to gravity drain. Suggest pumping or property acquisition.
11. **SR53 & St. Charles Road, NW corner** – Rear yard area adjacent to ComEd right-of-way tree nursery. Storm sewers and swales in area but more information needed.



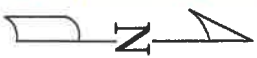
1. HAMMERSCHMIDT & NEW STREET



2. 100 BLOCK EAST WASHINGTON



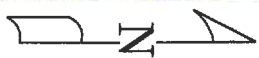
3. WASHINGTON, EDGEWOOD, MADISON, FAIRFIELD

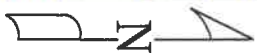

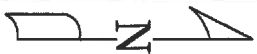

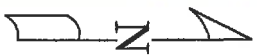
