

ORDINANCE NO. 7231

MODIFICATION TO VEHICLE IMMOBILIZATION ORDINANCE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Chapter 72 section 72.04 (B)(4) of the Village of Lombard Code of Ordinances is amended to the following:

"Pay fifteen dollars (\$15.00) per outstanding complaint/unpaid final determinations of vehicular regulation violation liability, and within 72 hours sign an installment agreement to pay the remainder of the amount owed over a period of time. If an installment agreement is not signed within 72 hours, the motor vehicle shall be subject to vehicle immobilization and the original amount (less any amount paid) shall be due. No further option under this subsection (B)(4) shall be available. Each payment made under an executed installment agreement will be applied to the total amount due and no one (1) or more outstanding complaint(s)/unpaid final determination(s) of vehicular regulation violation liability, shall be considered paid until the entire amount due for all outstanding complaints/unpaid final determinations of vehicular regulation violation liability, is paid. If payments are not made as required in the installment agreement, the agreement shall become void, the motor vehicle shall be subject to vehicle immobilization and the original amount due (less any amount paid) plus additional charges for vehicle immobilization shall become due. No further option under this subsection (B)(4) shall be available;"

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
