

## ORDINANCE NO. 5195

AN ORDINANCE READOPTING ORDINANCE NO. 5159 AND ORDINANCE NO. 5160, ADOPTED JUNE 20, 2002, RELATIVE TO THE ANNEXATION OF CERTAIN PROPERTIES BY THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS

(BOT 02-19: 21W035 North Avenue, 1N744 Route 53, 640 N. Route 53; BOT 02-20: 2N119, 2N133, 2N109, 2N081, 2N036, 2N041 Route 53 and 448 W. North Avenue)

WHEREAS, on the 20<sup>th</sup> of June, 2002, the President and Board of Trustees of the Village of Lombard have heretofore adopted Ordinance No. 5159, approving the annexation of 21W035 North Avenue, 1N744 Route 53, and 640 N. Route 53, Lombard, Illinois, pursuant to appropriate and legal notice; and,

WHEREAS, on the 20<sup>th</sup> of June, 2002, the President and Board of Trustees of the Village of Lombard have heretofore adopted Ordinance No. 5160, approving the annexation of 2N119, 2N133, 2N109, 2N081, 2N036, and 2N041 Route 53 and 448 W. North Avenue, Lombard, Illinois, pursuant to appropriate and legal notice; and,

WHEREAS, the President and Board of Trustees find it in the best interest of the affected property owners and of the Village to ensure that due process provisions associated with involuntary annexations are met; and

WHEREAS, notices of the Village of Lombard's intent to annex said property have since been sent to the appropriate parties by Certified Mail.

WHEREAS, all notices of said annexation, as required by Chapter 65 ILCS 5/7-1-1, have been resent to the appropriate parties in a timely manner as required by Statute (copies of said Notices being attached hereto as Exhibit "A" and made part hereof); and,

WHEREAS, it is in the best interest of the Village of Lombard that said territory be annexed thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Re: Readopting Ordinance 5159 and 5160 Page 2
SECTION 1: That the Village of Lombard readopts Ordinances 5159 and 5160 in their entirety.
SECTION 2: That the Department of Community Development is hereby directed to record a certified copy of this Ordinance, along with the Plats of Annexation, with the DuPage County Recorder of Deeds.
SECTION 3: That this ordinance shall be in full force and effect from and after its passage and approval as provided by law.
