BACKGROUND/POLICY IMPLICATIONS:

Platinum Bar and Grill Inc. d/b/a Overtime Bar and Grill located at 801 E. Roosevelt Road has transferred their interests to SNA Restaurant Group Inc. effective July 1, 2019 and has voluntarily not renewed their Class "A/B-III" liquor license for the July 1 through December 31, 2019 liquor licensing term.

SNA Restaurant Group Inc. d /b/a Sebastians Ale and Whiskey House located at 801 E. Roosevelt Road is requesting a Class "A/B-III-VG" liquor license for the July 1-December 31, 2019 licensing term.

Please find attached an Ordinance amending Title XI, Chapter 112, Section 112.13(A), effective July 1, 2019, relative to this request.

Staff is requesting a waiver of first reading due to the timing of the new liquor licensing term which begins July 1, 2019.

**SUBJECT: Request for a Class "A/B-III-VG" Liquor License
Sebastians Ale and Whiskey House – 801 E. Roosevelt Road**

As you are aware the Village of Lombard Board of Trustees on April 4, 2019 approved video gaming for certain liquor license classifications by Ordinance 7647.

Platinum Bar and Grill Inc. d/b/a Overtime Bar and Grill located at 801 E. Roosevelt Road currently holds a Class "A/B-III" liquor license which allows the sale of alcoholic beverages served with the primary purpose of the establishment being a restaurant.

Staff is currently in the process of renewing liquor licenses for the July 1 through December 31, 2019 liquor licensing term. Platinum Bar and Grill Inc. d/b/a Overtime Bar and Grill has informed staff that they have transferred their interests to a new corporation (Sebastians Ale and Whiskey House), effective July 1, 2019, and has decided to voluntarily not renew their Class "A/B-III" license for the upcoming liquor licensing term. The new corporation, SNA Restaurant Group Inc. d/b/a Sebastians Ale and Whiskey House applied for a new Class "A/B-III-VG" liquor license. Sebastians Ale and Whiskey House will operate as a restaurant serving steaks, seafood, pasta, burgers and comfort food.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing the number of entries in the Class "A/B-III" liquor license category by one and increasing the number of entries in the Class "A/B-III-VG" license category by one, effective July 1, 2019.

Staff is requesting a waiver of first reading due to the timing of the new liquor licensing term.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license, contained therein, to read as follows:

Class "A/B-III" - 13

This decrease in the number of Class "A/B-III" liquor licenses reflects the voluntary non-renewal of Platinum Bar and Grill Inc. d/b/a Overtime Bar and Grill located at 801 E. Roosevelt Road for the July 1 through December 31, 2019 licensing term and the termination of the Class "A/B-III" liquor license issued to Platinum Bar and Grill Inc. in relation thereto.

Section 2: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III-VG" liquor license, contained therein, to read as follows:

Class "A/B-III-VG" - 1

This increase in the number of Class "A/B-III-VG" liquor licenses reflects the issuance of a new Class "A/B-III-VG" liquor license to SNA Restaurant Group Inc. d/b/a Sebastians Ale and Whiskey House located at 801 E. Roosevelt Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
