## AN ORDINANCE AMENDING TITLE 15, CHAPTER 150, SECTION 150.030 OF THE VILLAGE CODE IN REGARD TO FIRE ALARM SYSTEM SUPERVISION

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 15, Chapter 150, Section 150.030 of the Lombard Village Code, which adopts by reference the International Building Code, 2000 Edition, and makes certain modifications thereto, is hereby amended by deleting all reference therein to Sections 924.1 and 924.2, and adding a new Section 912, which shall read in its entirety as follows:

"Add Section 912:

Section 912 – Fire Alarm System Supervision: All newly installed fire alarm systems shall be supervised by and tied directly to the Village of Lombard Communications Center (hereinafter referred to as "DuComm"). Fire alarm systems that are tied directly to DuComm as of January \_\_\_\_\_\_, 2011 [effective date of ordinance], shall be required to maintain said connection. Fire alarm systems that are using an approved central station fire alarm system monitoring service as of January \_\_\_\_\_\_, 2011 [effective date or ordinance] shall be required to tie directly to DuComm by January \_\_\_\_\_\_, 2017 [6 years after effective date of ordinance], or upon the expiration of the contract term with the service provider in effect on January \_\_\_\_\_, 2011 [effective date of ordinance], whichever occurs first."

**SECTION 2:** All ordinances and parts of ordinances in conflict with or inconsistent with the provisions of this Ordinance are hereby repealed to the extent of any such conflict or inconsistency.

**SECTION 3:** That if any part or portion of this Ordinance shall be declared invalid by court of competent jurisdiction, such invalidity shall not affect the remainder of this Ordinance.

<b>SECTION 4:</b> This Ordinance shall be in full	force and effect from and after its passage,
approval and publication in pamphlet form as provid	ed by law.
