**BACKGROUND**

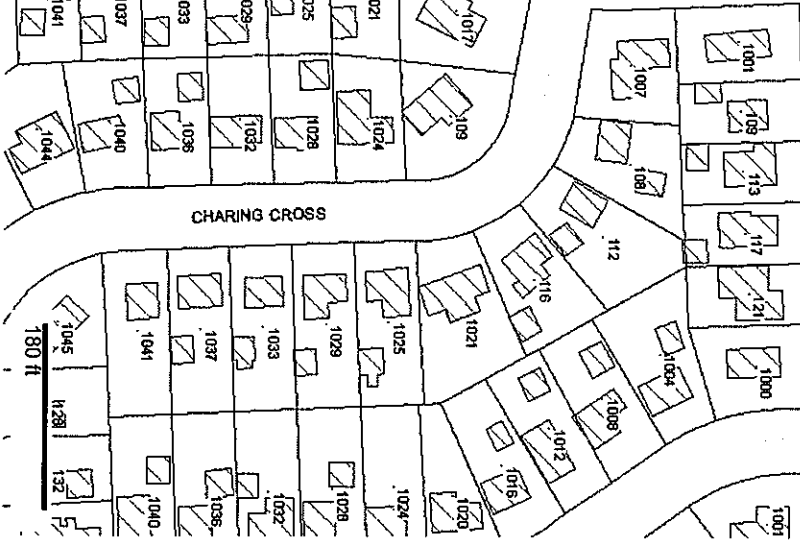
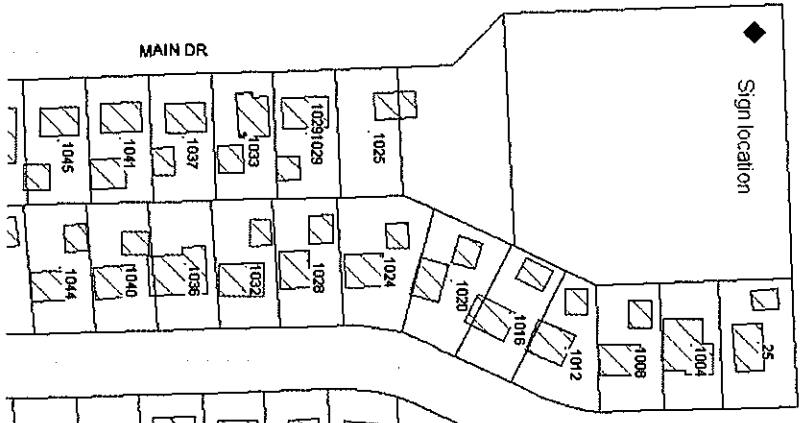
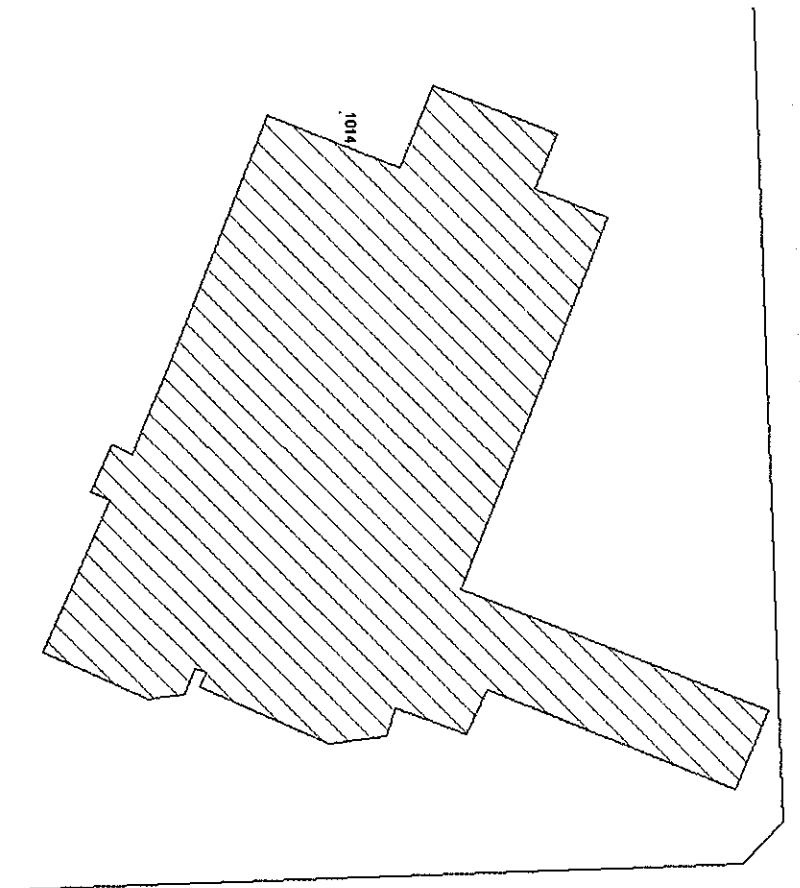
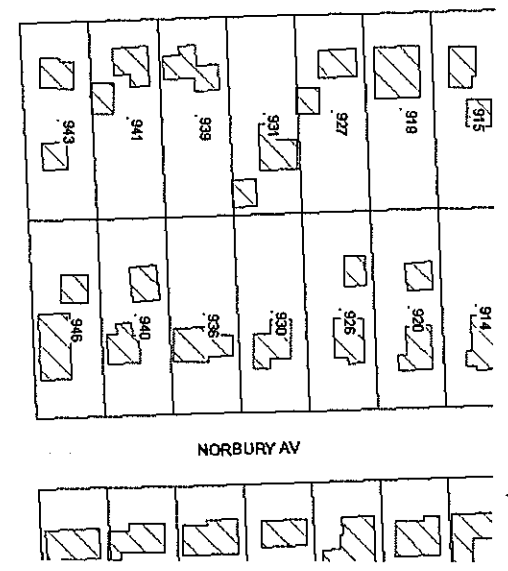
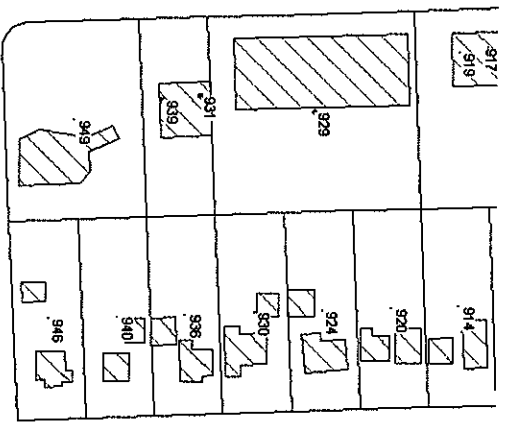
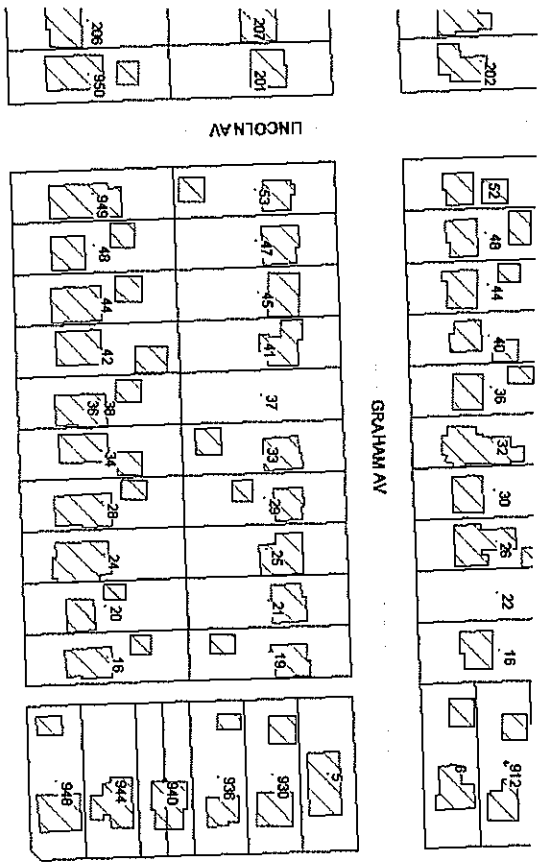
The Lombard Park District has recently submitted a request to place a temporary sign on the Village owned property located at the southeast corner of Main Street and Wilson Avenue. Back in the fall of 2009, the Village Board approved a similar request for the Jaycees Haunted House and LTC's Spooktacular signs.

The sign is intended to promote their "Gold Medal Celebration" which will be held on March 6, 2010. The temporary sign would be 4' x 8' and provide the name, date and location of the event. They are requesting the sign to be put up as soon as possible and be removed after March 6<sup>th</sup>.
