School

Previously, the Transportation and Safety Committee recommended installing additional parking restrictions and expanding restricted parking hours on certain streets surrounding Westmore School to the Village Board. In turn, the Village Board authorized the submitted modifications to the Traffic Code Ordinance. However, it has been brought to our attention by the Principal of Westmore School, that several existing parking restriction times were not extended along with the aforementioned actions, which are causing some confusion with the instituted traffic pattern around the school. Therefore, staff is recommending expanding the time for parking restrictions on streets surrounding Westmore School in support of and in accordance with the previously approved parking restriction times.
