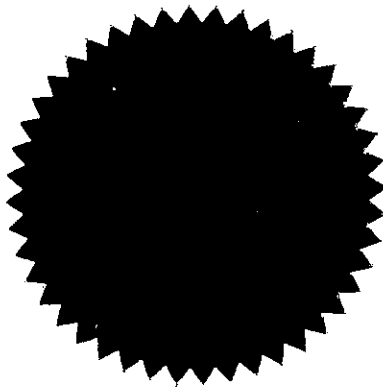

**AN ORDINANCE AMENDING TITLE 7, CHAPTER 70 OF THE LOMBARD VILLAGE CODE IN REGARD TO MOTOR VEHICLE LICENSING**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

SECTION 1: That Title 7, Chapter 70, Section 70.04(H) of the Lombard Village Code is

hereby repealed.

SECTION 2: That Title 7, Chapter 70 of the Lombard Village Code is amended by

adding a new Section 70.09 thereto which shall read in its entirety as follows:

"§70.09 VEHICLE LEASING AND/OR RENTING COMPANY VEHICLES.

(A) The Corporate Authorities hereby find that because of the large number of vehicles, the constant turn over of vehicles, the use of vehicles both within and outside of the Village and the various vehicle licensing requirements of the various municipalities in which vehicles owned by a large vehicle leasing and/or renting company are used, the licensing of large fleets of leasing and/or rental company vehicles pursuant to this Chapter must be handled in a special manner to properly license said vehicles without extensive administrative problems.

(B) Based on the foregoing, notwithstanding any other provision contained in this Chapter, the owner of any vehicle leasing and/or renting company that has its headquarters in the Village, and which has registered in excess of eight thousand (8,000) motor vehicles to a Village address, shall be required to purchase special rental vehicle license stickers, in lieu of the regular vehicle license stickers provided for in this Chapter and affix said special rental vehicle license stickers to those vehicles registered to a Village address; provided, however, no such special rental vehicle license sticker need be purchased for, or affixed to, a vehicle which, pursuant to an appropriate and valid ordinance, has affixed to it the vehicle license sticker of another Illinois City or Village.

(C) The following terms and conditions shall be applicable to the special rental vehicle license sticker referenced in subsection (B) above:

(1) The fee for said special rental vehicle license sticker shall be \$5.00 per vehicle.

(2) Said special rental vehicle license sticker shall be valid for a two (2) year period, running from January 1st of the first year through December 31st of the second year, with the first two (2) year licensing period beginning on January 1, 2003.

(3) Notwithstanding the fact that the special rental vehicle license sticker will be valid for less than a full two (2) year period, there shall be no proration of the fee set forth in subsection (1) above if the vehicle is purchased, and thereafter licensed, after January 1st during any given year.

(4) A late fee penalty fee of \$5.00 shall be assessed in relation to any vehicle which was owned on January 1st of any given year, should have been licensed under this Section, but for which no special rental vehicle license sticker was purchased prior to January 1st of said year."

SECTION 3: That this Ordinance shall be in full force and effect from and after its

passage, approval and publication in pamphlet form as provided by law.






