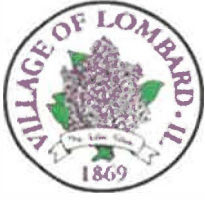

**SUBJECT:** **Liquor License Classification Changes**

On an annual basis, liquor license holders of a Class “A/B” license are required to report their annual gross dollars of alcohol sales. One of our liquor license holders is requesting a change in their current classification, effective with the July 1 through the December 31, 2024, licensing term:

Buca Restaurants 2, Inc. d/b/a/ Buca Di Beppo, located at 90 Yorktown Shopping Center, reported a consistent decrease in their annual sales for 2021, 2022, and 2023 which changes their current classification from an A/B-III to a Class A/B-II.

Attached is an Ordinance reflecting said changes, effective July 1, 2024.

Please place this item on the May 2, 2024, Village Board of Trustees agenda for consideration.

Staff is requesting a waiver of first reading to move the liquor license in the appropriate liquor classification for the July 1, through December 31, 2024 licensing term.

**ORDINANCE NO.**

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That, effective July 1, 2024, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “A/B-II” liquor licenses, contained therein, to read as follows:

Class “A/B-II” - 8

SECTION 2: That, effective July 1, 2024, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B-III liquor licenses, contained therein, to read as follows:

Class “A/B-III” – 9

SECTION 2: That the changes in the number of Class “A/B-II” and “A/B-III-” liquor licenses set forth in Sections 1 and 2 above are as a result of licensee Buca Restaurants 2, Inc. d/b/a Buca Di Beppo, located at 90 Yorktown Shopping Center, reporting gross dollars of liquor sales in calendar years 2021, 2022, and 2023, making a change from a Class “A/B-III” liquor licensee to a Class “A/B-II” liquor licensee appropriate.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
