**A RESOLUTION ABANDONING  
SPECIAL ASSESSMENT NO. 218B  
(ROADWAY IMPROVEMENTS – EDGEWOOD AVENUE,  
FROM CENTRAL AVENUE TO ROOSEVELT ROAD)**

WHEREAS, because of unresolved stormwater management issues, the Board of Local Improvements previously removed the roadway improvements relative to Edgewood Avenue, from Central Avenue to Roosevelt Road, from Special Assessment No. 218, and designated said Edgewood Avenue roadway improvements as Special Assessment No. 218B; and

WHEREAS, in order for the Village to proceed with Special Assessment No. 218B, certain storm sewer easements need to be acquired from two (2) property owners on Edgewood Avenue; and

WHEREAS, negotiations with the aforementioned two (2) property owners have come to an impasse; and

WHEREAS, the Board of Local Improvements does not desire to move forward with Special Assessment No. 218B as a joint condemnation/special assessment proceeding;

NOW, THEREFORE, BE IT RESOLVED by the Board of Local Improvements of the Village of Lombard, DuPage County, Illinois, that, based on the foregoing, the project known as Special Assessment No. 218B, consisting of roadway improvements to Edgewood Avenue, from Central Avenue to Roosevelt Road, is hereby officially abandoned.

BE IT FURTHER RESOLVED that should the roadway improvements to Edgewood Avenue, as proposed under Special Assessment No. 218B, be approved as a special assessment project by the Board of Local Improvements, at a future date, the Board of Local Improvements shall, at such time, assign a new special assessment number to said project.




