Replacement of PD Booking Room Toilet /Water Coolers/Sinks

I am requesting that we replace the current prisoner Acorn toilet/water coolers in booking which were purchased in 1977. The use and 28 year old stainless steel toilets by the prisoners have taken a toll on the units. They are in a dilapidated shape and are leaking and discolored. The water fountain/hand wash sink water supply had to be turned off due to leaking and constant running water. Repairs to the system are not an option. All vendors that came out and looked at the units agreed that no repairs can be made and they need to be replaced due to failing internal parts and the age of the units. The plumbing for prisoner devices is a specialized product and only handled by a few vendors.

The Department of Corrections performs annual audits on our facility to make sure that we are meeting the State mandates. To ensure we meet these mandates the units must be replaced.

Funds were set aside during the budget process of \$8,200. The current cost of steel material is on the rise and fluctuates with the demand. At this time, I have locked in a price from Elmco/Chicago. Three quotes were obtained with Elmco/Chicago being the lowest at \$11,000. The other two were \$14,500 and \$20,550. All three vendors quoted the Acorn Replacement Penal-Ware units. The additional monies (\$2,800) will come from Capital Improvement Fund where \$40,000 for plumbing repairs for the police department building has been allocated.

I am requesting a waiver of bids authorizing the purchase of the Acorn Replacement-Ware toilet combo units.
