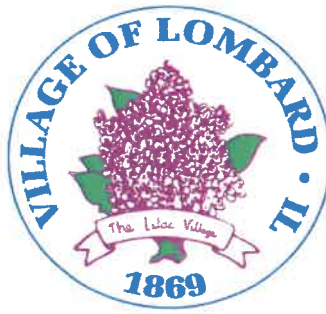

ORDINANCE NO. 8208

**AN ORDINANCE APPROVING A WATER PURCHASE AND SALE
CONTRACT BETWEEN THE DUPAGE WATER COMMISSION AND
CONTRACT CUSTOMERS**

WHEREAS, the Village of Lombard is a current customer of the DuPage Water Commission (the “Commission”) pursuant to the Water Purchase and Sale Contract Between the DuPage Water Commission and Charter Customers dated June 11, 1986 (the “Original Contract”); and

WHEREAS, the Original Contract expires on February 24, 2024;

WHEREAS, the Commission and current customers desire and intend to enter into a new Water Purchase and Sale Contract Between The DuPage Water Commission and Contract Customers (the “New Contract”), attached hereto as Exhibit 1 and incorporated as if fully set forth herein, whereby the Commission will supply water to the customers according to the terms and conditions of the New Contract negotiated between them; and

WHEREAS, the President and Board of Trustees, deems it to be in the best interests of the Village and its residents to approve and enter into the New Contract.

Now, Therefore, Be It Ordained by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, in the exercise of its authority, as follows:

Section 1: The foregoing recitals are hereby incorporated herein and made a part hereof as findings of the Village Board.

Section 2: The Water Purchase and Sale Contract Between The DuPage Water Commission and Contract Customers attached hereto and by this reference incorporated herein and made apart hereof as Exhibit 1, shall be and hereby is approved and ratified.

Section 3: The Village President is hereby authorized and directed to execute the Water Purchase and Sale Contract Between The DuPage Water Commission and Contract Customers attached as Exhibit 1 on behalf of the Village.

Section 4: This Ordinance shall be in full force and effect from and after its adoption.


