## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

# BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 9

This decrease in the number of Class "A/B-II" liquor licenses reflects the termination of the "Class A/B-II" liquor license issued to Djont/Ept Leasing LLC d/b/a Discovery Bay Restaurant located at 707 E. Butterfield Road, due to new ownership of the restaurant.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 10

This increase in the number of Class "A/B-II" liquor licenses reflects the issuance of a new Class "A/B-II" liquor license to FelCor Lombard Lessee, L.L.C. d/b/a Discovery Bay Restaurant, located at 707 E. Butterfield Road, Lombard, IL.
