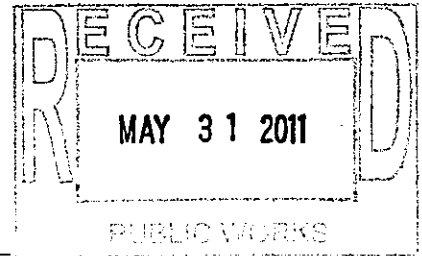


VILLAGE OF LOMBARD

TREE & STUMP REMOVAL

CONTRACT DOCUMENT NUMBER PWO 1214



This agreement is made this 19th day of May, 2011 by and between, and shall be binding upon, the Village of Lombard, an Illinois municipal Corporation hereinafter referred to as (the "Village") and (Ciosek Tree Service, Inc.) hereinafter referred to as (the "Contractor").

Witnesseth That in consideration of the mutual promises of the parties delineated in the Contract Documents, the Contractor agrees to perform the services and the Village agrees to pay for the following services as set forth in the Contract Documents:

TREE <u>STUMP</u> REMOVAL ONLY (From Trees Removed by Village Crews) STUMP DIAMETER INCHES IN DIAMETER AT GRADE	\$ <u>3.00</u> Per Inch
TOTAL CONTRACT PRICE:	\$ <u>27,750.00</u>

The Village agrees to pay, and the Contractor agrees to accept as full payment for the services which are the subject matter of this Contract the total sum of \$ 27,750.00 paid in accordance with the provisions of the Local Government Prompt Payment Act and the provisions of the Contract Documents.
3. Contractor shall not delegate the duties involved in the performance of the services which are the subject matter of this Contract without the written approval of the Village.
4. This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.
5. Where the terms of this Contract conflict with the provisions of the Contract Documents, the Contract Documents shall be binding.
