**ORDINANCE \_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:**

**Section 1:** That effective April 1, 2021, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license, contained therein, to read as follows:

Class "U" - 2

This increase in Class "U" liquor licenses reflects the issuance of a Class "U" liquor license to Tuxedo T-Shirt, LLC who will be operating the business commonly known as NachoRita located at 14 W. St. Charles Road, Lombard.

**Section 2:** That effective April 1, 2021, this Ordinance shall be in full force and effect from and after its passage and approval as required by law.

**SUBJECT:** Request for a Class "U" Liquor License  
NachoRita – 14 W. St. Charles Road

The Village has received a request for a Class "U" liquor license from Tuxedo T-Shirt, LLC d/b/a NachoRita located at 14 W. St. Charles Road. The Class "U" liquor classification allows alcoholic beverages to be served as an adjunct to food service with no package sales allowed. NachoRita will be a fast casual, take-out and delivery small restaurant that will offer Tex-Mex cuisine. Their intent is to serve beer, sangria and margaritas (as well as other Mexican style cocktails) to complement their menu.

Attached is an ordinance increasing the Class "U" liquor license category by one, effective April 1, 2021, and issuing a Class "U" liquor license to Tuxedo T-Shirt, LLC d/b/a NachoRita. The petitioner is requesting a waiver of first reading.
