**SUBJECT: Request for a Liquor License – Thai Sushi Inn
719 E. Roosevelt Road**

True Star Inc. d/b/a Rokki Japanese Cuisine located at 719 E. Roosevelt Road currently holds a Class "U" liquor license which allows them to serve alcoholic beverages served as an adjunct to food service with no packaged sales allowed. The Village has been notified that Rokki Japanese Cuisine sold their business on October 6, 2014 to new owners. As a result of this change in ownership, True Star, Inc. surrendered their Class "U" liquor license and the new owner, Golden 1 Inc. d/b/a Thai Sushi Inn has applied for a Class "U" liquor license.

Attached is an ordinance reflecting said change of ownership. A waiver of first reading is being requested by the applicant due to time constraints.

ORDINANCE _____

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class U" liquor license, contained therein, to read as follows:

Class "U" - 1

This decrease in Class "U" liquor license reflects the sale of True Star, Inc. d/b/a Rokki Japanese Cuisine located at 719 E. Roosevelt Road and the termination of the Class "U" liquor license issued to Rokki Japanese Cuisine in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license, contained therein, to read as follows:

Class "U" - 2

This increase in Class "U" liquor licenses reflects the issuance of a Class "U" liquor license to Golden 1 Inc. who is operating the business commonly known as Thai Sushi Inn located at 719 E. Roosevelt Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
