SUBJECT: Title XI, Chapter 112, Section 112.12(A) of the Lombard Village Code in regard to Use of a Limited Menu under the Class "S" Liquor License Category

Noon Whistle currently holds a Class "S" liquor license. Village Code Title XI, Chapter 112, Section 112.12(A) defines the Class "S" liquor classification as follows:

"Class "S" – The manufacturing of beer products on the licensed premises, for consumption on the licensed premises, along with the sale of said beer products manufactured on the licensed premises, as well as beer products manufactured by the licensee off of the licensed premises, for consumption off of the licensed premises. In addition to beer products manufactured on the licensed premises, beer, cider, wine and spirits not manufactured on the licensed premises may be sold for consumption on the licensed premises; provided, however, spirits may only be sold for consumption on the licensed premises: (i) at special events, not open to the general public; or (ii) as a single "spirits drink of the day" to the general public, provided that, for the "spirits drink of the day," no more than one drink type containing spirits (i.e., a Manhattan) shall be sold to the general public for consumption on the licensed premises on any day that the licensed premises are open to the public. Tasting of all alcoholic beverages sold on the licensed premises are allowed. A kitchen, offering food service to the public at all times while the licensed premises is open for business, except for the last hour during which the licensed premises is open to the public, and providing food service relative to special events not open to the public, is required. Catered food may be brought in relation to special events not open to the public."

The proposed Ordinance, if adopted, will now remove the limits on spirits sold for consumption on the licensed premises and will no longer include a "spirits drink of the day" for consumption on the licensed premises at special events, not open to the general public; or (ii) as a single "spirits drink of the day", no more than one drink type containing spirits (i.e. a Manhattan) shall be sold to the general public for consumption on the licensed premises on any day that the licensed premises are open to the public, as noted above, and to include an adequately staffed full-service commercial kitchen, offering food service to the public at all times from a reasonably full menu, while the licensed premises is open for business,

except for the last hour during which the licensed premises is open to the public. However, a limited menu of three (3) hot and freshly prepared items, which shall contain at least one entrée and one appetizer, may be offered to the public during business hours on Mondays, Tuesdays and Wednesdays, and until 4:00 p.m. on Thursdays. Cold sandwiches, prepackaged snacks and items heated in a microwave shall not qualify as one of the three (3) required items of a limited menu. Catered food may be brought in relation to special events not open to the public.

Staff is requesting a waiver of first reading.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.12(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO USE OF A LIMITED MENU UNDER THE CLASS "S" LIQUOR LICENSE CATEGORY

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended, relative to the description of the Class "S" liquor license category, to read in its entirety as follows:

"Class "S"—The manufacturing of beer products on the licensed premises, for consumption on the licensed premises, along with the sale of said beer products manufactured on the licensed premises, as well as beer products manufactured by the licensee off of the licensed premises, for consumption off of the licensed premises. In addition to beer products manufactured on the licensed premises, beer, cider, wine and spirits not manufactured on the licensed premises may be sold for consumption on the licensed premises. Tasting of all alcoholic beverages sold on the licensed premises is allowed. An adequately staffed full-service commercial kitchen, offering food service to the public at all times from a reasonably full menu, while the licensed premises is open for business, except for the last hour during which the licensed premises is open to the public, is required. However, a limited menu of three (3) hot and freshly prepared items, which shall contain at least one entrée and one appetizer, may be offered to the public during business hours on Mondays, Tuesdays and Wednesdays, and until 4:00 p.m. on Thursdays. Cold sandwiches, prepackaged snacks and items heated in a microwave shall not qualify as one of the three (3) required items of a limited menu. Catered food may be brought in relation to special events not open to the public. Video gaming, as provided for under the Illinois Video Gaming Act, shall not be allowed on the licensed premises."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
