Village Code in Regard to the Number of Public Passenger Licenses

Flat Rate Cab Dispatch Inc. has applied for a license to operate a Taxi Company within the Village of Lombard. The business license application along with their operating rules and insurance information have been provided. Also attached is Flat Rate Cab's rates and fare fees.

Ms. Toni DePerte, President of Flat Rate Cab Dispatch Inc. will be present at the Board meeting for any questions or concerns.

Attached is an Ordinance increasing the number of Public Passenger licenses to twelve (12). Please place this item on the Consent Agenda for the February 7, 2013, Board of Trustees meeting. Waiver of first reading is requested.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 121, SECTION 121.03 OF THE LOMBARD VILLAGE CODE IN REGARD TO PUBLIC PASSENGER LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 121, Section 121.03 (A) (2) of the Lombard Village Code is amended to read as follows:

(2) Number

Brigitte O'Brien Village Clerk

There shall be twelve (12) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of granting a business license to Flat Rate Cab Dispatch Inc. d/b/a Flat Rate Cab Dispatch located at 330 E. Roosevelt Road, Lombard, Illinois.

Flat Rate Cab Policy

- 1. All Dues/Lease Fees are due on Mondays, any credit overage will be paid the following Monday.
- 2. Drivers are not allowed to give out personal cell phone numbers.
- 3. Drivers are responsible for any damage on a Flat Rate Vehicle while in possession. (See attachment.)
- 4. Drivers are to be courteous and respectable to customers at all times.
- 5. Drivers are not allowed to ask any personal questions regarding personal matter to our customers.
- 6. Drivers must maintain an open communication with dispatch (ie lunch break, personal time off.)
- 7. Drivers must answer the phone during their shift; dispatch will attempt to call 3 times, if no answer you will be taken out of rotation.
- 8. Drivers are not allowed refuse any rides at any time.
- 9. All rides that are pre-signed to Drivers must call 10-8 45 minutes prior to pick up. If driver doesn't call 10-8 they are 10-X for 24 hours. **No Exceptions**
- 10. Drivers are to assist customers with any baggage or luggage on airport transportation.
- 11. Drivers are not allowed to over charge customers.
- 12. Drivers are not allowed to refuse credit cards from customers.
- 13. Drivers are not allowed to Short Block.
- 14. Drivers are not allowed to be continuously late to orders.
- 15. Drivers must keep a clean car inside and out. Inspections are on Monday's (see attachment)
- 16. Drivers must call dispatch to say 10-6 and clear.
- 17. Drivers must call when they are 10-8 and 10-7.
- 18. Drivers must call dispatch to report when they have a 10-1 walk ups.

Owner Operator Vehicles

Must maintain Commercial Insurance at all times and Flat Rate Dispatch Inc. must be added to the insurance policy.
