The FY 2007 budget includes replacement of ST343, a single axle dump truck with plow. The bid results are as follows:

Public Works received two sealed bids. Freeway Ford was low bidder. The bid price for the 2007 tandem axle dump truck with plow is \$162,945 less a trade-in allowance of \$20,350 equals a net total bid of \$142,595. The budgeted amount for this vehicle is \$160,000.

I recommend the award of a contract to Freeway Ford of Lyons, IL. in the amount of \$142,595. I also recommend declaring village unit number SM328, A 1994 Ford tandem axle dump truck with plow, as surplus per the attached ordinance and authorizing its trade-in. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the April 6, 2006 meeting.
