**SUBJECT: Request for a Class "C" Liquor License
Louisiana Crab Shack – 275 W. Roosevelt Road**

The Village has received a request for a Class "C" liquor license (beer and wine) from Louisiana Crab Shack Lombard LLC d/b/a Louisiana Crab Shack located at 275 W. Roosevelt Road (formerly Roundhouse Restaurant). Louisiana Crab Shack currently has 7 locations in Texas, one in Chicago and is expanding to other states. Their menu will offer Cajun seafood including shrimp, calamari, crab, crawfish, oysters, gumbo, etc. The restaurant will be full-service, have approximately 120 seats and be open for business 7 days a week.

Attached is an ordinance increasing the Class "C" liquor license category by one and issuing a liquor license to Louisiana Crab Shack Lombard LLC d/b/a Louisiana Crab Shack.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 7

This increase in Class "C" liquor licenses reflects the issuance of a Class "C" liquor license to Louisiana Crab Shack Lombard LLC who will be operating the business commonly known as Louisiana Crab Shack located at 275 W. Roosevelt Road, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
