SCHEDULE VII - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS		
In accordance with Section 10-13-6 and when signs are erected giving notice thereof, no person shall, at any time, park a vehicle upon any of the following streets or parts of streets:

DELETE: St. Charles Rd.	West curb line of Westmore/Meyers Rd.	East curb line of Garfield St.
Both Sides	Westmore/Meyers Rd.	East curb line of Garfield St.
ADD: St. Charles Rd.	West curb line of Westmore/Meyers Rd.	East curb line of Garfield St.
South Side	Westmore/Meyers Rd.	East curb line of Martha St.
ADD: St. Charles Rd.	West curb line of Westmore/Meyers Rd.	East curb line of Martha St.
North Side	Westmore/Meyers Rd.	

The Committee voted to recommend an increase in the St. Charles Road parking space availability between Garfield and Martha Streets, which will create approximately eight (8) new parking spaces. This action requires an ordinance to the Traffic Code as follows.

On August 3, 2009, the Transportation and Safety Committee discussed parking conditions on St. Charles Road between Garfield Street and Craig Place. Specifically, parking on St. Charles Road in this area is prohibited at all times. Additional on-street parking has been requested to assist with attracting business opportunities on the north side of St. Charles Road.

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:
