

ORDINANCE 4591 AN ORDINANCE PROVIDING FOR THE ABATEMENT OF A PORTION OF THE TAX LEVY

WHEREAS, the Village of Lombard, a municipal corporation, has heretofore issued its General Obligation Bonds dated November 1, 1989, in the amount of \$1,000,000; and

WHEREAS, the Village of Lombard has funds available for the purpose of retiring (a portion of the) principal and interest of the bonds aforesaid that was to be paid from the proceeds of the 1998 tax levy, said principal and interest totaling \$53,300.00.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

Section 1: That the tax levy to be extended for the year 1998 for the purpose of paying principal and interest of the General Obligation Bonds dated November 1, 1989, aforesaid, be and the same is reduced and abated in the amount of \$53,300.00.

Section 2: That a certified copy of this Ordinance be filed forthwith with the County Clerk of DuPage, Illinois.

Section 3: That this Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.

We, the undersigned, being the duly qualified and acting President, Village Clerk and Treasurer, respectively, of the Board of Trustees (the "Board") of the Village of Lombard, DuPage County, Illinois (the "Village"), having been directed and authorized by the Board to prepare and file this Certificate, do hereby certify and notify you as follows:

- 1. That the Village has heretofore issued \$1,000,000 aggregate original principal amount of its General Obligation Bonds, Series 1989 for various Village purposes as authorized by Ordinance 3190 passed by the Board on October 5, 1989 (the "Prior Bonds Ordinance").
- 2. That the Village has levied taxes in amounts sufficient to pay maturing principal and interest on said bonds.
- 3. That a portion of said bonds (the "Prior Bonds") are presently outstanding in an aggregate principal amount of \$850,000 and that portion has not been refunded.
- 4. That pursuant to the provisions of Section 7, Article VII of the 1970 Constitution of the State of Illinois and an pursuant to Ordinance 4454 passed by the Board on May 7, 1998, the Board has authorized the issuance of \$935,000 General Obligation Refunding Bonds, Series 1998B, dated May 15, 1998 (the "Refunding Bonds").
- 5. That the proceeds of the Refunding Bonds will be used for the purpose of refunding all of the Prior Bonds described as follows:

General Obligation Bonds, Series 1989 dated November 1, 1989 being all of the bonds outstanding of an issue in the original principal amount of \$1,000,000 fully registered and without coupons, due serially on December 30 of the years and in the amount and bearing interest at the rates per annum as follows:

- 6. That you are hereby notified and directed to make proper reduction of the taxes heretofore levied for each of the years 1998 through 2004 (collectible in 1999 through 2005), for the payment of the Prior Bonds by abating such taxes in their entirety.
- 7. That only the Prior Bonds of the Village described in paragraph 5 are being refunded, and the taxes levied to pay any other bonds of the Village should not be abated at this time.
- 8. That the ordinance adopted by the Board on the 7th day of May, 1998, authorizing the Refunding Bonds (the "Bond Ordinance") prescribed all details thereof and provides for the levy and collection of a direct annual tax upon all the taxable property within the Village sufficient to pay the principal thereof and interest thereon as the Refunding Bonds mature.
- 9. That a certified copy of the Bond Ordinance was been filed in your office on the 20th day of May, 1998, as County Clerk of The County of DuPage, Illinois, and constitutes the authority for the extension and collection of the taxes to pay the principal and interest on the Refunding Bonds.

ORDINANCE 4592 AN ORDINANCE PROVIDING FOR THE ABATEMENT OF A PORTION OF THE TAX LEVY

WHEREAS, the Village of Lombard, a municipal corporation, has heretofore issued its General Obligation Bonds dated May 15, 1998, in the amount of \$935,000; and

WHEREAS, the Village of Lombard has funds available for the purpose of retiring (a portion of the) principal and interest of the bonds aforesaid that was to be paid from the proceeds of the 1998 tax levy, said principal and interest totaling \$58,472.50.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

Section 1: That the tax levy to be extended for the year 1998 for the purpose of paying principal and interest of the General Obligation Bonds dated May 15, 1998, aforesaid, be and the same is reduced and abated in the amount of \$58,472.50.

Section 2: That a certified copy of this Ordinance be filed forthwith with the County Clerk of DuPage, Illinois.
