AN ORDINANCE AMENDING TITLE III, CHAPTER 33, SECTION 33.24 OF THE LOMBARD VILLAGE CODE IN REGARD TO RESIDENTIAL DWELLING PROXIMITY REQUIREMENTS FOR THE FIRE DEPARTMENT

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title III, Chapter 33, Section 33.24 of the Lombard Village Code is amended to read in its entirety as follows:

"§ 33.24 Residential dwelling proximity requirement.

- (A) The Fire Chief shall be required to reside within the Village or within four (4) miles of any point on the corporate boundary of the Village.
- (B) Any person appointed to the position of Fire Chief, who does not meet the requirement of this Section at the time of appointment, shall have one (1) year to come into compliance with this Section from the date of appointment. The Village Manager shall have the discretion to grant said person additional time to come into compliance with this Section based on a showing of hardship."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
