ORDINANCE
AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "E1" liquor license, contained therein, to read as follows:

Class "E1" - 0

This decrease in Class "E1" liquor license reflects a classification change to Whirly West Inc. d/b/a Whirly Ball located at 800 E. Roosevelt Road, Lombard.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B II" liquor license, contained therein, to read as follows:

Class "A/B II" - 9

This increase in Class "A/B II" liquor license reflects the issuance of a Class "A/B II" liquor license to Whirly West Inc. d/b/a Whirly Ball located at 800 E. Roosevelt Road, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
