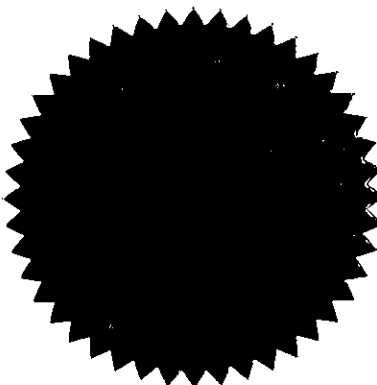

ORDINANCE 5024

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE  
LOMBARD VILLAGE CODE IN REGARD TO LIQUOR LICENSE  
CLASSIFICATIONS (RESTAURANT/BREW PUB)

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code

is amended by revising the description for the Class "Z" liquor license to read in its entirety as

follows:

"Class "Z" - Alcoholic beverages served as an adjunct to food service at a location that also brews beer on the licensed premises. The sale of beer brewed on the licensed premises for carry-out shall be allowed in containers of not larger than sixty-four (64) ounces in size; with all other package sales prohibited. (Restaurant/Brew Pub)"

**SECTION 2:** That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code

is amended by revising the entry relative to a Class "Z" liquor license to read as follows:

"Class "Z" - \$2,500.00"

**SECTION 3:** That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code

is amended by revising the entry relative to the Class "Z" liquor license to read as follows:

"Class "Z" - 1"

This increase in Class "Z" liquor licenses reflects the issuance of a Class "Z" liquor license to Taylor

Brewing Company located at 717 East Butterfield Road, Lombard, Illinois.

**SECTION 4:** That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code

is amended by revising the entry relative to the Class "A/B-III" liquor license to read as follows:

"Class "A/B-III" - 9"

This decrease in Class "A/B-III" liquor licenses reflects the change in the liquor license issued to Taylor Brewing Company, located at 717 East Butterfield Road, Lombard, Illinois, from a Class "A/B-III" liquor license to a Class "Z" liquor license.

**SECTION 5:** That this Ordinance shall be in full force and effect from and after its passage,

approval and publication in pamphlet form as provided by law.






