ORDINANCE NO.

AN ORDINANCE AMENDING TITLE 3, CHAPTER 33, SECTION 33.24(A) AND TITLE 3, CHAPTER 34, SECTION 34.27(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO THE RESIDENTIAL DWELLING PROXIMITY REQUIREMENT FOR CERTAIN MEMBERS OF THE FIRE AND POLICE DEPARTMENTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 3, Chapter 33, Section 33.24(A) of the Lombard Village Code is amended by deleting the words "a five (5) mile radius of the intersection of Main Street and Wilson Avenue in the Village.," as contained therein, and replacing said words with "the Village or within four (4) miles of any point on the corporate boundary of the Village."

SECTION 2: That Title 3, Chapter 34, Section 34.27(A) of the Lombard Village Code is amended by deleting the words "a five (5) mile radius of the intersection of Main Street and Wilson Avenue in the Village.," as contained therein, and replacing said words with "the Village or within four (4) miles of any point on the corporate boundary of the Village."

SECTION 3: That this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
