BACKGROUND/POLICY IMPLICATIONS:

Request for 15 Minute Parking, 14 W. St. Charles Road (Balkan Bakery)

The owner of the Balkan Bakery, Dragica Mitic, requested that one parking space in front of her business be restricted and posted to allow 15 minute parking only. Her reason for this was to allow for her customers to make quick stops to patronize her business. In response to this, the PSTC asked the police department to investigate the feasibility of designating several parking spaces in the downtown area as being 15 minute parking to allow for patrons to make quick stops. This was done to avoid showing favoritism towards any specific business and in anticipation of similar requests in the future from other downtown businesses.

During the October 2nd, 2017 meeting, the police department proposed designating between four and six parking spaces on Park Ave. north of St. Charles Rd. as 15 minute parking to allow citizens to park and make quick visits to downtown businesses. The PSTC chose to recommend that three spaces on the west side of Park Ave. and three spaces on the east side of Park Ave. be designated as 15 minute parking.

Ordinance No.

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule X (T) (new section) of the Lombard Traffic Code (Ordinance 1186) is amended to add the following restriction:

(T) In accordance with Section 10-13-10 and when signs are erected giving notice thereof, no person other than customers to local businesses shall park a vehicle and no vehicle shall be parked for a period exceeding fifteen (15) minutes between the hours of 7:00 a.m. and 7:00 p.m. on any day except holidays in any of the following places:
