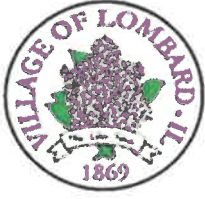

**SUBJECT: Request for a Decrease in the Number of Class “A” Coin-Operated Licenses
Brauer House and Lombard Roller Rink**

The Village Code, Title XI, Chapter 110, Section 110.21(C) has two categories for the Coin-Operated Amusement Devices, Classes A and B, with the following number of allowances:

Class A – Four to Eight Coin-Operated Amusement Devices

Class B – More than Eight Coin-Operated Amusement Devices

Prior to the current Business Licensing Term, July 1 -June 30, 2025, there were three (3) Class A and three (3) Class B licenses issued. Two of the licensees, Brauer House with eight devices and Lombard Roller Rink with six, held a Class A license.

Both establishments are no longer conducting business as of 2024; therefore, staff is requesting to decrease the Class A category by two.

Attached is an Ordinance reflecting the decrease of licenses allowed, from three (3) to one (1). The remaining license is held by Troika Brewing Company, d/b/a Noon Whistle.

Please place this item on the July 18, 2024, Village Board of Trustees agenda for consideration.

Staff is requesting a waiver of first reading to reflect these changes due to the Board of Trustees summer schedule.

ORDINANCE NO.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 110,
SECTION 110.21(C) OF THE LOMBARD VILLAGE CODE
IN REGARD TO THE NUMBER OF
CLASS A COIN-OPERATED LICENSES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:**

SECTION 1: That Title XI, Chapter 110, Section 110.21(C) of the Lombard Village Code is hereby amended to read as follows:

(C) In addition to the license required by subsection (B) for each individual coin-operated amusement device, there shall be issued no more than the stated number of annual licenses in the following classifications for persons, firms, corporations or associations displaying for public patronage or keeping for operation any coin-operated amusement device:

Class A

Four to eight coin-operated amusement devices.

No more than ~~three~~ one licenses.

SECTION 2: That this ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
