Subject: FY23 SOURCEWELL Cooperative Contract Equipment Purchase

Included in the FY23 budget is the replacement for Village unit number WT451, a 2012 John Deere 524K front end-loader. The new loader, model number 524P, is available for purchase through the SOURCEWELL Cooperative Contract #032119-JDC at a considerable discount. Since John Deere will price guarantee this purchase until delivery in January of 2023, issuing a purchase order now will help avoid a scheduled and future price increases. The SOURCEWELL pricing is available through our local dealer, West Side Tractor of Naperville (IL). The contract price for the loader is \$185,269.20 plus \$17,141.00 in additional options for a total price of \$202,410.20. Trade-in allowance for the current loader is \$70,000 so the net cost of this purchase would be \$135,150.57. Budgeted amount for this purchase is \$245,000.

I recommend the BOT waive bid and award a contract to West Side Tractor of Naperville (IL) in the amount of \$135,150.57 for a new John Deere 524P front end-loader. I also recommend declaring Village unit number WT451 as surplus per the attached ordinance and authorize its trade-in. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the May 26, 2022 meeting.
