BACKGROUND/POLICY IMPLICATIONS:

Attached for your consideration is an ordinance amending Title XI, Chapter 112, Section 112.13(A) (effective July 1, 2022) relative to liquor license classification changes for Nine Six 96 LLC d/b/a Rosemary and Jeans, located at 116 S. Main Street due to an increase in their 2021 annual gross dollars of alcoholic liquor sales and SNA Restaurant Group, Inc. d/b/a Sebastians Ale and Whiskey House, located at 801 E. Roosevelt Road due to a decrease in their 2021 annual gross dollars of alcoholic liquor sales.

Staff is requesting a waiver of first reading in order to bring the number of licenses in each liquor license category current for the July 1, through December 31, 2022, liquor licensing term.

SUBJECT: Liquor License Classification Changes

On an annual basis, liquor license holders of a Class “A/B” license are required to report their annual gross dollars of alcoholic beverage sales. Two of our liquor license holders require a change in their current classification, effective with the July 1 through the December 31, 2022 licensing term:

Nine Six 96, LLC d/b/a Rosemary and Jeans, located at 116 S. Main Street, reported an increase in their 2021 sales which changes their current classification from a Class “A/B-I” to a Class “A/B-II”.

SNA Restaurant Group, Inc. d/b/a/ Sebastians Ale and Whiskey House, located at 801 E. Roosevelt Road, reported a decrease in their 2021 sales which changes their current classification from a Class “A/B-III-VG” to a Class “A/B-II-VG”.

Attached is an Ordinance reflecting said changes, effective July 1, 2022.

Staff is requesting a waiver of first reading to move the liquor license in the appropriate liquor classification for the July 1, through December 31, 2022 licensing term.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That, effective July 1, 2022, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “A/B-I” liquor licenses, contained therein, to read as follows:

Class “A/B-I” – 4

SECTION 2: That, effective July 1, 2022, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B II liquor licenses, contained therein, to read as follows:

Class “A/B-II” – 7

SECTION 3: That, effective July 1, 2022, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “A/B-III-VG” liquor licenses, contained therein, to read as follows:

Class “A/B- III-VG” – 1

SECTION 4: That, effective July 1, 2022, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “A/B-II-VG” liquor licenses, contained therein, to read as follows:

Class “A/B- II-VG” – 3

SECTION 5: That the changes in the number of Class “A/B-I”, “A/B-II”, “A/B-III-VG”, and “A/B-II-VG” liquor licenses set forth in Sections 1, 2, 3, and 4 above are as a result of Nine Six 96, LLC d/b/a Rosemary and Jeans located at 116 S. Main Street reporting an increase in their gross dollars of liquor sales in calendar year 2021, resulting in a change from a Class “A/B- I” liquor licensee to a Class “A/B-II” liquor licensee and SNA Restaurant Group, Inc. d/b/a Sebastians Ale and Whiskey House, located at 801 E. Roosevelt Road, reporting a decrease in their gross dollars of liquor sales in calendar year 2021, resulting in a change from a Class “A/B-III-VG” liquor licensee to a Class “A/B-II-VG” liquor licensee.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
